NOTICE PURSUANT TO SECTIONS 9 AND 10 OF THE SDI ORDINANCE

1. The Exchange has been informed that pursuant to a deed dated 18th February, 1994 ("Deed") entered into between (1) Choi Sai Leung ("Choi"), (2) Francis Yuen Tin Fan ("Yuen"), (3) Kee Shing (Holdings) Limited ("Kee Shing"), (4) Li Ka Shing ("Li") and (5) Larry Yung Chi Kin ("Yung"), Choi has, inter alia, irrevocably and unconditionally grants to Yuen, Kee Shing, Li and Yung jointly the exclusive option ("Put Option"), exercisable at any time during the period of 30 days commencing from 19th August, 1994 to require Choi to purchase the following shares and/or warrants in Seapower beneficially owned by the other parties and/or the entities controlled by the other parties respectively in consideration of the payment of HK\$3.30 per share and HK\$2.08 per unit warrant:-
