- N1 Presently, the Administrative Trustee of the THT holds 33,464,697 ordinary shares of the Company which were derived as a result of a scheme of arrangement of Orient Overseas (Holdings) limited ("OOHL") in July 1992. On August 25, 1994, the Administrative Trustee transferred 16,981,838 ordinary shares of the Company to beneficiaries of the Tung Holdings Trust (THT) in exchange for such beneficiaries' interests in the THT in accordance with the Amended and Restated Trust Deed of the THT.
- N2 90,287,389 shares were transferred from Hsin Chong Holdings (BVI) Limited to Key Finance Limited which in turn transferred those shares to its shareholders. 10,618,193 shares were allotted due to election for scrip in respect of 1993/94 final dividend.
