- N1 A Subscription Agreement has been entered into on 15/01/97 between Lai Sun Development Company Limited ("LSD") and Lai Sun Garment (International) Limited ("LSGI") pursuant to which LSD will allot 165,000,000 ordinary shares of HK\$0.50 each at the price of HK\$12.00 per share to LSGI subject to certain conditions being satisfied on or before 30/01/97.
- N2 A conditional agreement has been entered into on 15/01/97 between LSD and Lim Por Yen pursuant to which LSD has been agreed to purchase from Mr.Lim 5,000 Class "B" shares of Lucky Strike Investment Limited for a total consideration of HK\$1,000 million, which consideration is to be satisfied by the allotment and issue of 79,051,383 ordinary shares of HK\$0.50 each in the capital of LSD to Mr.Lim as the price of HK\$12.65 per share, subject to certain conditions being fulfilled on or before 31/01/97.
- N3 Acquisitions were made from 23/01/97 to 27/01/97 at prices ranging from \$1.04 to \$1.10 per share.
