N2 Pursuant to an agreement dated 1 May 1997 entered into between Lam Kwok Yan and Lam Kwok Hing (together "Messrs. Lam"), Chan Chin Geoffrey F. Paterson, Lai Kwok Lam and Yick Shu Kau (together the "Vendors") and Optimist International Limited ("Optimist"), the Vendors sold to Optimist an aggregate of 133,421,000 shares of HK\$0.10 each (the "Sale Shares") in the share capital of Process Automation (Holdings) Limited (the "Company") on 15 May 1997. The Vendors are all directors of the Company and the Sale Shares represent their entire interests in the issued share capital of the Company, apart from 309 shares of HK\$0.10 each continued to be held by Geoffrey F. Paterson. The transaction was announced by the Company on 3 May 1997. Medusa Group Limited, in which Messrs Lam each have 50% interest, control 66.22 per cent of the voting rights of Optimist. Each of Messrs Chan Chin Geoffrey F. Paterson, Lai Kwok Lam and Yick Shu Kau holds less than one-third of the voting rights of Optimist.

N3 Acquisitions were made from 14/05/97 to 15/05/97 at prices ranging from \$1.96 to \$2.00 per share.
