- N1 On 7 September 1997, Ho Hung (also known as Chelsea Ho)("Ho"), the sole registered shareholdings of Georgia Technologies Limited ("GTL"), a company incorporated in the British Virgin Islands, entered into a deed (the "Deed") with GIL and Xin Nan (H.K.) Trading Development Co. Ltd. ("Xin Nan"), agreeing to pledge, charge and mortgage all her shares in GTL in favour of Xin Nan. Pursuant to the Deed, Ho executed an instrument of transfer in connection with all her shares in GTL and tendered it to Xin Nan. Subsequent to signing of the Deed and the instrument of transfer, advice was sought from the Counsel in the British Virgin Islands as to the legal effect of execution of such documents and it is now determined that Xin Nan is to be regarded as being entitled to exercise or control the exercise of 100% of the issued share capital of GTL. GTL is the beneficial owned of 770,469,230 shares in Seajunion Holdings Ltd ("SHL").
