- N1 On 30 September 1997, an agreement was entered into among Mr. Paul Ng Kwok Cheung ("Mr. Ng"), Paliburg Holdings Ltd ("Paliburg") and Rapid Growth Holdings Ltd ("Rapid Growth"), pursuant to which Paliburg agrees to sell to Rapid Growth 71,584,000 shares in Chi Cheung Investment Co Ltd ("Chi Cheung"), and Mr Ng agrees to sell to Rapid Growth 85,935,168 shares and 7,640,000 warrants in Chi Cheung. The said transactions are to be completed on or before 14 October 1997. Rapid Growth is owned as to 50% by each of Paliburg, through Latest Trend Ltd, and Mr Ng. As a result of the transactions, Paliburg will hold, through Rapid Growth, notifiable interests of a total of 157,519,168 shares in Chi Cheung.
