- N1 On 30 September 1997, a Sale and Purchase Agreement was entered into among Mr Ng Kwok Cheung Paul ("Mr Ng"), Paliburg Holdings Ltd ("Paliburg") and Rapid Growth Holdings Ltd ("Rapid Growth") pursuant to which Mr Ng and Paliburg has agreed to sell to Rapid Growth securities in Chi Cheung Investment Company Ltd.

Up to 31 December 1995, 1,000,000 shares had been transferred to and beneficially owned by Dr Tan Boon Tou. Further 1,000,000 shares were transferred to transferred to Dr Tan Boon Tou on 15 October 1997. The remaining 3,000,000 shares were to be transferred to Dr Tan Boon Tou within the period of five years from the date of the agreement subject to the terms of the agreement.
- N13 As a consequence of the purchases of shares by a wholly-owned subsidiary of John Swire & Sons (HK) Ltd and based on the number of shares in issue at the close of business on 23 October 1997 following the repurchases made by Swire Pacific Ltd ("the Company") of its 'A' and 'B' shares up to that time, the percentage level of the interest of John Swire & Sons Ltd in the 'B' shares of the Company has increased from 63.1% to 64% and in the voting right of the Company from 49.3% to 50%
