- As a consequence of the purchases of shares by a wholly-owned subsidiary of John Swire & Sons (HK) Ltd and based on the number of shares in issue at the close of business on 23 October 1997 following the repurchases made by Swire Pacific Ltd ("the Company") of its 'A' and 'B' shares up to that time, the percentage level of the interest of John Swire & Sons Ltd in the 'B' shares of the Company has increased from 63.1% to 64% and in the voting right of the Company from 49.3% to 50%
