- N1 CNT (through its subsidiary) accepted the voluntary cash offer by Stagecoach Asia Ltd on 19/02/99.

- N3 (a) On 18 January 1999, CNT entered into an agreement with Stagecoach Asia Limited ("Stagecoach") and others for, among other things : (1) the sale by CNT (through Golden Brilliance Investments Ltd ("GBI")) to Stagecoach of 20,000,000 Citybus shares at HK\$1.95 per share; and (2) the giving of an irrevocable undertaking by GBI in respect of 558,931,353 Citybus shares to accept a voluntary conditional general offer by or on behalf of Stagecoach for all the Citybus shares at HK\$1.95 per share. The sale of 20,000,000 Citybus shares was completed on 22 January 1999.
- (b) On 18 January 1999, CNT entered into an agreement with China Travel International Investment Hong Kong Ltd whereby the parties agree, inter alia to waive or procure the waiver of any restrictions on transfer or disposal (including pre-emption rights) which exist in relation to the 113,450,000 shares in Citybus held by Tedworth under a share agreement dated 6 March 1997. Accordingly, the agreement previously constituting an agreement falling within S.9 of the SDI Ordinance was terminated on 18 January 1999.
