- N2 Following the acceptance by CNT Group Limited (through its subsidiary) of the voluntary cash offer made by Stagecoach Asia Ltd on 19 February 1999, Rapid Growth Ltd ceased to be deemed to be interested in 37,926,000 shares in CNT Group Limited held by Citybus Finance Company Limited, a wholly-owned subsidiary of Citybus Group Limited.
- N3 CNT (through its subsidiary) accepted the voluntary cash offer by Stagecoach Asia Limited on 19/02/99.
- N4 CIM Company Limited exercised its option under the subscription agreement dated 26/06/98 to subscribe for 250,000,000 further shares in the listed company and nominated Pippen Limited to take up those shares.
- N5 Staverley Assets Limited exercised its option under the subscription agreement dated 25/05/98 to subscribe for 300,000,000 further shares in the listed company.
- N6 The right to acquire interest in 500,000,000 shares in the listed company was disclosed on 1 June 1998, while 250,000,000 shares and another 250,000,000 shares in the listed company were actually acquired on 30 November 1998 and 25 February 1999 respectively.
