("Silver Tree"), Mr. Wang Kin Chung Peter ("Mr. Wang") and Mr. Jack Chi Chien Tang ("Mr. Tang"), Silver Tree, as consideration for the sale of the entire issued share capital of Keycar Company Limited, was allotted on 8 April 1999 a total of 139,596,834 Shares. Silver Tree is beneficially wholly owned by Mr. Wang. Pursuant to the same Agreement, Mr. Wang becomes a director of Tristate with effect from 8 April 1999. The Agreement is a section 9 agreement. Accordingly, by virtue of section 10 of the SDI Ordinance, in addition to the interest disclosed above, Mr. Wang also taken to be interested in the interest of Mr. Tang in the Shares apart from the Agreement which includes:
